COMMUNITY SERVICES AGREEMENT

This Agreement is entered this 14th day of December, 2020 by and between FAIRFIELD TOWNSHIP, TIPPECANOE COUNTY, INDIANA ("TOWNSHIP") and Lafayette Lions Club, an Indiana non-profit corporation ("CORPORATION");

WHEREAS, IC 36-6-4-8 provides that a Township Trustee/Executive may use township funds for all categories of community services, if these funds are appropriated for community services by the Township boards; and, the Township Trustee/executive may agree to partner for services with corporations providing health and community services not specifically provided by another government entity; and,

WHEREAS, Corporation is an Indiana non-profit corporation engaged in providing the community services that are not offered by another government entity; to wit: to provide services and supplies for those in need from eye exams, provisions of eyeglasses, ocular surgical assistance, Hearing aids and hearing assistance items, mobility assistance for visually impaired, assistance in obtaining leader dogs, preschool vision screening programs, along with any other services or supplies the Corporation oversees in and for Fairfield Township residence; and,

WHEREAS, the Trustee finds that the citizens of the Township are in need of the services offered by Corporation and that there is no other government entity that is designated to provide those services

WHEREAS, the Trustee wishes to enter into a community services agreement and partner with Corporation to provide the health and/or community services to the citizens of Township;

NOW THEREFORE, IT IS AGREED AS FOLLOWS:

- 1. Corporation shall provide the supplies and/or community services described herein to the citizens of Township effective immediately.
- 2. In consideration for the provision of the health and/or community services provided herein, Township shall pay to Corporation, the sum of Five Thousand, Four Hundred Dollars (\$5,400), which shall be payable as follows: by check, on or before December 31st, 2020.
- 3. Corporation shall provide a yearly detailed report by January 31st, 2022 listing the number of individuals described herein served on or before the 31st of December 2021, or up until all monies are used, along with a report of expenses disbursed for residents that live within Fairfield Township boundaries.
- 4. Corporation shall acknowledge and give due credit to Township in its publicity, interviews, advertising, news releases, and fiscal reports.
- 5. Corporation is an independent contractor and is not performing the health and/or community services as an agent of Township. Corporation agrees to indemnify and hold Township harmless from any claims, actions or causes of action, including reasonable attorneys' fees and costs of defense, which may be brought against Township arising from or relating to the services provided by Corporation.

NOW THEREFORE, BE IT RESOLVED that the Fairfield Township Trustee/Executive hereby approves in the amount of Five Thousand, Four Hundred Dollars (\$5,400) for use by Corporation in providing the community services herein, and the Trustee/Executive is hereby authorized to pay those funds to Corporation for that purpose.
